Southern Georgia Communities Encouraged To Apply for PlanFirst

PlanFirst, administered through the Georgia Department of Community Affairs (DCA), is a program designed to recognize and reward communities that clearly demonstrate an established pattern of successful implementation of their Local Comprehensive Plan. Having PlanFirst designation yields many benefits for communities, including the opportunity to apply for Community Development Block Grants (CDBGs) each year for three successive years, bonus points on various DCA programs, and reduced interest rates on GEFA loans.

PlanFirst applications are due by May 15 of each year. To apply, local governments must prepare a 22-page application that describes how well the jurisdiction implements projects which are specifically listed in the Work Program of its Comprehensive Plan. Applicants who are selected will host a site visit from the DCA PlanFirst committee to showcase the

Work Program projects that have been implemented. Applicants must be Qualified Local Governments with an approved Service Delivery Strategy and must be current on all required reports to DCA. For more information, and to apply, visit https://www.dca.ga.gov/local-government-assistance/planning/local-planning/planfirst. The SGRC can provide assistance with *PlanFirst* applications for communities in our region.

The City of Fitzgerald was recently awarded *PlanFirst* designation for the 2019-2021 time period, and the City of Douglas was redesignated. Other recent *PlanFirst* designees in this region include: Cook County and the Cities of Adel and Tifton.

Transportation & Environmental



Douglas Sidewalk Master Plan & Current Transportation Projects

The Southern Georgia Regional Commission Transportation Department staff is currently developing a Sidewalk Master Plan for the City of Douglas. This initiative is funded by a contract with the Georgia Department of Transportation for bicycle and pedestrian planning. SGRC staff will be in the field this month, actually walking the streets, to gain first-hand experience regarding pedestrian transportation in Douglas. Staff will then combine field notes with existing data and information to develop a priority list of sidewalk projects. This list will focus both on smaller projects like closing gaps

in sidewalks to larger sidewalk projects that connect major destinations. Given the proven benefits of walking for health and wellbeing, more sidewalks will contribute to making Douglas a healthier and happier community. The Master Plan is expected to be finished by May of 2020.

Elsewhere in the region, the Transportation staff is working on the following projects:

- designs for a new bicycle trail in Tifton
- parking study for Valdosta and Lowndes County
- update of the Valdosta-Lowndes MPO Transportation Plan
- Complete Streets or bike/walk friendly community trainings
- analysis of crashes near schools in Charlton, Cook, and Echols Counties to identify any potential roadway improvements that are related to school traffic

Geographic Information Services (GIS)

Drone Technology Services Offered at SGRC

The Southern Georgia Regional Commission GIS department now offers Drone Technology services to communities in the region. SGRC-GIS currently has two FAA certified drone pilots on staff who are ready to assist with small project aerial photography needs. SGRC-GIS's pilots are equipped and trained to safely fly the drones and to use best practices to capture needed information during flights. SGRC-GIS currently has a Phantom 4 Pro v 2 drone with a 4K camera that takes quality photos and videos.



Why use drones? A UAV, or Unmanned Aerial Vehicle (a drone) is able to reach or view areas that are not easily accessible, like the tops of buildings, water towers, tree canopies, detention ponds, etc. They are also extremely helpful during damage assessment after a weather emergency or fire, when damaged buildings or roads are too dangerous for human access. For example, drone flights over a flooded roadway can help emergency managers better assess the situation and determine which equipment and personnel would be safe and appropriate to dispatch.

Large aerial projects require planning prior to flight to be successful. Before SGRC-GIS staff arrives, flight plans are created around the target area. The drone will be set to take photos intermittently, as it flies, to ensure enough overlap between the photos. This will create a complete, large, high-resolution aerial image and maybe even a 3D model.

SGRC-GIS has flown a wide variety of projects over the last 2 years. Some examples include: a soccer facility in Lowndes County, a boat ramp along the Alapaha River, newly paved roads, building construction, utility facilities, and the City of Folkston Cemetery. In projects where high-resolution imagery is crucial, such as mapping cemetery headstones that are only a few feet apart, drone imagery is ideal. Drone imagery and videos can also be beneficial for mitigating environmental impacts of road and utility projects.

Information Technology (IT)

SGRC-IT Division Offers Helpful Advice to Local Governments on Assessing IT Needs

Many local governments are beginning to plan their budgets for a new fiscal year. An old adage, attributed to Benjamin Franklin, is beneficial to remember during this process and that adage is, "Failure to plan, is planning to fail." While this may apply to all aspects of local government, it is especially true for IT assets that a government relies upon to function. Therefore, IT support and hardware replacement should be an important part of a local government's FY2021 budget.

While incidental IT-related problems will arise from day to day, IT technicians often respond to critical IT issues that are entirely avoidable, more costly, and more disruptive simply because an upgrade, replacement of software, or hardware was not planned for.

At this time of year, local governments are encouraged to take a serious look at the computers and IT infrastructure they rely on to keep going each day. By taking an objective look at both resources and needs, local governments can take steps to avoid unplanned emergencies and unexpected upgrades.

The following questions are a helpful starting point for local governments to internally assess their IT needs and to in turn accurately plan for the IT needs in the coming fiscal year, while they are planning their FY2021 budgets.

Self-Assessment of IT Needs:

- In critical service areas, what are the ages of the desktops and servers being used?
- Are any of the above out of manufacturer warranty?
- Are any critical services provided on computers running an unsupported operating system or software?
- Do all computers on the network have up-todate virus protection?
- Does your replacement cycle for computers and servers extend beyond 5 years?
- Do you have a regular backup schedule for critical servers and staff computers?
- Are you confident that your network switches, routers, and other devices are labeled, organized, and not reaching the end of their engineered life?
- What software support and upgrades are you paying for but not using? Why?

Once a local government has assessed its IT needs, the SGRC-IT Division can provide assistance to help plan the next steps.

Larry Adams, SGRC Director of IT Services, reminds local governments, "SGRC-IT encourages everyone to view and maintain IT infrastructure just like all other tools that are vital to local governments. A computer upgrade may not generate the excitement within a department that a new patrol car, bucket truck, or even new office furniture does, but it is a necessary part of doing business that must be planned for."
