City of Patterson Awarded CDBG-RDF Grant For Downtown Renewal Project

The City of Patterson recently received \$258,612 in Community Development Block Grant Redevelopment Funds (CDBG-RDF) to assist with the elimination of slum and blight in the downtown area. Portions of two dilapidated buildings, located on Railroad Avenue and owned by the City, will be demolished and rebuilt while several existing walls will be stabilized. Completion of this work will enable the City to construct a pocket park with public seating and a concert space as well as restrooms within the building shells. The total cost for this downtown renewal project is \$718,752. The final design work is underway and construction should be completed by next spring in time for the concert season.

The successful CDBG-RDF grant application was written and submitted by the Southern Georgia Regional Commission. SGRC Community and Economic Development staff will administer the project.

The CDBG-RDF program is administered by the Georgia Department of Community Affairs (DCA). This program provides local governments access to flexible financial assistance to help them implement projects that cannot be undertaken with the usual public sector grants and loans. Unlike other DCA CDBG programs, the RDF uses the CDBG national objective of "elimiminating slums or blight." As a result, many smaller scale projects (in downtown areas or blighted industrial areas) may be competitive for RDF financing.



SGRC Local Government Services Provides Training to Planning Commission Members

The SGRC Local Government Services Division offers training for newly appointed Planning Commission members within the region. Local Government Minimum Performance Standards require that all Planning Commissioners receive training within one year of their appointment. The training is also offered as a refresher course, is available for any community in the SGRC region, and usually takes about two hours. The training can be held at either SGRC office location (Valdosta or Waycross), or can be conducted on-site in any community within the SGRC region.

During the training, participants learn about Zoning Procedures Law, Robert's Rules of Procedures, and how to conduct a formal meeting. Time is allotted to answer questions and discuss issues that each community may have. Also covered in the training are the roles of the Planning Commission, Zoning Board of Appeals, and elected officials. The training can be combined with any other municipality or county government in the SGRC region.


Geographic Information Services (GIS)

SGRC GIS Completes Baselining in Twenty Georgia Jurisdictions

In cooperation with the Georgia Geographic Information Office (GIO), the SGRC GIS Division completed a process known as "baselining" for twenty jurisdictions in the state, eight of which were in pilot are-

as. The baselining process measures the readiness of the area to support the core functionality of Next Generation 911. Over time, it helps to track progression toward standardized, seamless state datasets. Using data from the baselining process allows each jurisdiction to determine how close it is to being able to route calls and validate locations, both collectively as well as community by community.

The datasets baselined include addresses, road centerlines, and the following administrative boundaries: PSAP (Public Safety Answering Points) and emergency service boundaries (Law, Fire, EMS).



SGRC-GIS Baselining Pilot Project Areas

Attribute validations were checked on all of the layers. Most layers had geometry checks, road centerlines also went through network checks. Address points were checked against addresses and roads. All of the baselining took around a day per jurisdiction. Multi-county data was then combined and baselining was completed on that combination. The GIS Division produced maps for the pilot areas.

The GIO office held meetings in each pilot area and service providers were invited. Providers could see each fire boundary, for example, along county boundaries and work to make them align. Specific comments were added as bookmarks in a database. The GIS Division then corrected the boundaries per the comments held at the meetings. The three pilot project areas where workshops were held are: the Greater Athens Pilot area (including Athens-Clarke County, Barrow County, Oconee County), the Coastal Pilot area (including Chatham County, Bryan County, and Ft. Stewart), and the Crisp-Dooly Pilot area (including Crisp County and Dooly County).

Small Business Lending

SGRC Small Business Lending Division Shares Loan Program Benefits

The SGRC Loan Program works in conjunction with the banking industry to provide "gap" financing (capital) for new and expanding businesses. The goal of the program is to create jobs, improve the tax

base, and create public/private partnerships.

There are three federal agencies which provide funding for the SGRC Loan Program: the Small Business Administration (SBA), the Economic Development Administration (EDA), and the Rural Development (RD) Department of Agriculture.

Eligibility of the project, loan amount, and collateral requirements may vary from program to program, and the SGRC Small Business Lending Division can assist with most commercial businesses.



The SGRC is a Certified Development Corporation (CDC) under

the SBA-504 Loans program. This loan program is for fixed asset financing only. The Bank funds fifty percent, the SGRC/SBA funds forty percent, and the borrower invests an amount ranging from ten to fifteen percent. The maximum amount of a loan is \$5 million for the SBA portion and the SBA-504 loan is often used for real estate financing.

Some advantages offered by the SBA-504 are low down payments, fixed interest rates, and longer terms on the portion financed by SGRC/SBA. Allowing the borrower to make a lower down payment may provide an advantage by freeing up working capital for the borrower. There is also protection from rate increases, which makes it easier for the bank to loan more to the business as it grows.

The SGRC is the lender for the EDA and RD Revolving Loan Fund, which is primarily fixed asset financing. The SGRC has an internal pool of \$6 million in EDA and USDA Rural Development funded revolving loan funds. The maximum loan amount is \$500,000 and loans must be leveraged with other sources. For example, the loan can consist of forty percent Revolving Loan funds, fifty percent bank funds, and ten percent funds invested by the borrower. There are limited funds available.



TIA In the Southern Georgia Region: GDOT TIA Staff Presents TIA Impacts on Transportation Investment

The Transportation Investment Act (TIA) Referendum, locally known as T-SPLOST, allows the implementation of a one-percent sales tax for 10 years. Funds raised by the tax are used solely for transportation purposes. In 2018, TIA was passed by voters in the Southern Georgia Region. This one-percent sales tax increase is being used to fund various transportation projects that are located throughout the region.

TIA has been actively collecting

revenue for over three years in the Southern Georgia Region. The revenue collected from October 2018 through February 2022 has remained above projected estimates and currently totals \$207,199,057. Of this total, \$155,399,293 is being applied to projects on the transportation investment list. The investment list has a total of 151 transportation projects that are located throughout the region, of which 62 projects have been completed and 21 are in construction and scheduled to be completed within the next few months.

Also, discretionary TIA funds distributed to all local governments in the SGRC region total \$51,799,764. These funds are being used to help local governments maintain the transportation network as well. Many local governments are improving local roads, building multi-modal facilities, and purchasing capital equipment for maintaining the roads. Included in this article are pictures of capital equipment purchased by Pierce County and Irwin County with TIA discretionary funds.

Due to TIA revenue being higher than estimated and projects being completed sooner than expected, there is a possibility that the current TIA may end 1-2 years earlier than anticipated. For this reason, there has been a request by the Citizens Review Panel to consider kicking off the TIA-2 process

sooner rather than later.

Kenneth Franks of the GDOT TIA office and his staff will present current TIA revenue and project information at the Southern Georgia Regional Commission Council meeting in April to provide an overall update. Franks' presentation will highlight the impact of TIA in the region, especially in the areas of improving transportation safety, network reliability, and regional connectivity.
