## **Geographic Information Services**

#### SGRC-GIS Receives Special Achievement in GIS Award

In preparation for and during the 2020 Presidential Election, the SGRC-GIS staff assisted multiple election offices throughout the region with a variety of mapping needs. Those mapping needs included

interactive web maps that depicted polling locations and electoral boundaries, road and address assistance, maps, and even participation in a statewide initiative that partnered with the Environmental Systems Research Institute (Esri), the Georgia Geographic Information Office, and the Georgia Secretary of State. The SGRC-GIS' multi-pronged approach to assist election offices helped prepare for the election and provided support up to and on election day.

Esri is an international supplier of geographic information system software, web GIS, and geodatabase management applications. The company is headquartered in Redlands, California.

Each year, prior to the annual user conference, Esri solicits nominations for outstanding users of the software. Nominations are made by industry managers, Esri regional offices, and international distributers.

#### Success Story in Valdosta: The Georgia Beer Company

The Department of Community Affairs (DCA) has published its Story Map for 2021 Success Stories. Submissions for Success Stories are due each March and include submittals from regional commissions,

PlanFirst communities, and local jurisdictions. The 2021 Success Stories Regional Commission DCA Story Map is available here: Regional Commission Success Stories 2021 (arcgis.com).

The SGRC's Success Story about Georgia Beer Company, located at 109 S. Briggs Street in downtown Valdosta, is featured in the DCA Story Map for 2021. The SGRC Lending Division, in participation with Commercial Banking Company, helped secure an SBA 7a loan to finance the brewing equipment. Below follows additional detail regarding this successful project.

Initially, the City of Valdosta was approached by a group of entrepreneurs who wanted to establish a microbrewery in one-of-three potential cities in southern Georgia or northern Florida. The poten-

tial small business owners met with City of Valdosta staff to discuss renovating the former Waterworks building (constructed circa 1900).

Later, the business partners worked with the Small Business Development Center to develop a business plan and pro forma and ultimately found private investors to assist with efforts to redevelop the 7,400 square foot building, originally constructed to mimic Italian Renaissance architecture. The property is located just west of the Valdosta Main Street downtown area in the Valdosta Historic District. The location is within the Community Activity Center Character Area in the Comprehensive Plan, as well as a Community Commercial Zoning district, which permits microbreweries bottling up to 15,000 barrels of beer per year.

The Georgia Beer Company opened its taproom and beer garden in 2019 and seeks to utilize as many Georgia Grown ingredients as possible in their many varieties of beer. The presence of a microbrewery in a Main Street/downtown area has been seen as an indicator of a healthy local economy by employing local residents, adding to the local economy, enabling craft beer tourism, and encouraging in-migration of new residents. #### City of Tifton Breaks Ground for New Youth Center

The City of Tifton held a ground breaking ceremony on August 12 at the future site of its new Youth Center in South Tifton. In 2020, SGRC's Community and Economic Development staff assisted the City

in applying for \$750,000 in CDBG funds to construct the center, which will host an after-school program and summerfeeding program for children in the Matt Wilson neighborhood, as well as Adult Literacy classes for neighborhood residents. completion, Upon this project will benefit over 250 children, youth, and adults.

In regards to the event Mayor Julie Smith said, "On behalf of the City of Tif-

ton we are beyond thankful to be breaking ground on the Youth Center project. We've been working on this idea for several years now, and to know that soon the families of the surrounding area will have a functional facility to enjoy is very exciting. I'm grateful to our partners at the Tift County School system for working with us, and especially grateful to our Urban Redevelopment Board for their ongoing work to make a positive impact that will benefit our citizens."

The project was made possible by partnerships with the TiftArea YMCA, Southern Regional Technical College, and Community Development Block Grant funding from the Georgia Department of Community Affairs. SGRC will continue to take an active role in the project by assisting the City of Tifton in grant administration.

#### SGRC Environmental Program Announces Lake Beatrice Improvements Feasibility Study in Ben Hill County

Located in Ben Hill County, Lake Beatrice was identified by the Suwannee Satilla Regional Water Planning Council as a potential location to address the reduction of surface water flow gaps in the Alapaha River. This would be accomplished by improving the dam at Lake Beatrice.

Initial estimated calculations indicated improvements to the dam could reduce flow gaps, in both frequency and severity, at the downstream Statenville Node in Echols County. The SGRC's Lake Beatrice Improvements Feasibility Study will gather data to determine improvements needed at the dam and lake to reduce these gaps and will consider what operations and ownership models are possible from the improvements.

To determine if this is, in fact, a viable project for implementation, the Southern Georgia Regional Commission (SGRC) and the United States Army Corps of Engineers (USACE), along with the partnership of the Suwannee-Satilla Regional Water Planning Council, the owners of Lake Beatrice, and many other regional partners agreed to participate in a study funded by the Georgia Environmental Protection Division (GAEPD) through a State SEED Grant to determine the feasibility of addressing the future water supply needs of the river by implementing dam improvements. ## **Small Business Lending**

#### New SBA 504 Debt Refinance Rules Announced

Rex Dorsey, Director of the SGRC Small Business Lending Division, recently announced that there are now new SBA 504 Debt refinance rules in effect. Dorsey said, "For all of the following changes, the term 'qualified debt' refers to originally eligible 504 uses of proceeds, meaning fixed assets."

For debt refinance with an expansion, a business may now refinance 100% of its existing debt. Previously, an expanding business could only refinance 50% of existing qualified debt with an expansion.

For debt refinance without expansion, the debt being refinanced now must be at least six months old to be eligible for refinance. Previously, the qualified debt being refinanced had to be 2 or more years old to be eligible. Additionally, in the past a 504 debt refinance project did not allow for the refinance of previous federal debt. However, now, any previous federal debt (including SBA 7A loans and existing SBA 504 loans) may be refinanced.

A "substantial benefit test" must be met, reducing the borrower's payment by a minimum of 10%, for both SBA 7A loans and SBA 504 loans. Also, for SBA 7A loans, the existing 7A lender must verify in writing that it is unwilling or unable to modify the current payment schedule and for SBA 504 loans, both the Third Party Loan and the 504 Loan must be refinanced, or the Third Party Loan must have been paid in full. Finally, refinance without expansion 504 loans are capped at \$75,000 per full time employee.

Due to COVID-19, the requirement that the qualified debt not be past due in the past year has been waived. Anyone who feels they may have an eligible project is encouraged to call the SGRC Lending Division at (229) 333-5277.

The action can be big or as small because when it relates to dementia, every action counts.
