2. Section 06 1643 – Gypsum Sheathing; Para. 2.01; Add the following:

- "C. As an alternative, the General Contractor will have the option to install DensElement Barrier System, as manufactured by Georgia-Pacific Gypsum, in lieu of the specified Gypsum Sheathing and fluid-applied weather barrier system. "
- 3. Section 07 2726 Fluid-Applied Membrane Air Barriers; Para. 2.01; Add the following:
 - "C. As an alternative, the General Contractor will have the option to install DensElement Barrier System, as manufactured by Georgia-Pacific Gypsum, in lieu of the specified Gypsum Sheathing and fluid-applied weather barrier system. "

A. Add to paragraph 2.01.A: "4. Tennessee Valley Metals, Inc."

5. Section 27 5116 – Sound Reinforcement System;

A. Paragraph 2.02.E: Change "2000 rms watts" to "200 rms watts".

6. Section 28 3100 – Fire Alarm System;

A. Paragraph 2.01.A: Add additional manufacturer "Honeywell Gamewell FCI".
